Dear Sir/ Madam,

Following our conversation with Mr Sani on Friday November 24th regarding project Maison I, we sent the email below in which we explained our situation with the transfer of funds and in which we indicated that we can pay for 1 unit, unit number 1216 and cancel the other 3 units.

We were told that we would get a reply from your company by Monday November 27th. Unfortunately, we didn't receive any reply from your side till today November 28th.

Therefore, we came to your office today and sat with Mr. Sani again and discussed our proposal. Mr Sani has indicated that the management does not accept our offer. They do not agree to transfer the 400,000AED that has already been paid to one unit in this case unit number 1216 and receive the remaining amount 169,000AED from us within 2 days.

We are not asking for a refund but we're asking to transfer the paid amount to 1 unit and cancel the other 3 units.

But if you do not agree then we're forced to take legal actions.

In addition, I would like to point out the following:

- There is no official launch for this project
- There's no project number for this project in the Dubai Land Department registered.
- No Escrow account for this project.
- There's no SPA signed.

Above all we haven't signed any agreement/documents whatsoever.

We hope we can resolve this matter mutually. We are still keen on taking unit 1216 and we would like to invest more in the future. We don't want this matter to become an issue amongst our relationship.
