The amount of six thousand dirhams was estimated as a deposit for the expert's expenses and fees, which the plaintiff was charged to pay. A session was set for 11/21/2023 to consider the case in the event of non-payment of the deposit, and the 14th session -12-2023 to deposit the report in case it is paid, provided that the expert presents the report to the parties to the dispute after completing it and receives their objections to it, and researches and responds to them before submitting the final report to the court.
